Open letter of protest to President Boni Yayi, Head of State, Head of Government and the Minister of Foreign Affairs, African Integration, Francophonie and Beninese Abroad: Mr. Nassirou Arifari BAKO against collaboration of sending delegation from Africa to repatriate compatriots refugees in Germany. That is nonzero only to serve his country , the beloved country.

His Excellency, Mr. President,
Mr. Minister,

We have just learned with bitterness and total horror, that following a hearing in Berlin "Landesamt für Bürger-und Ordnungsangelegenheiten (LAB) Friedrich-Krause-Ufer 24 13353 Berlin" in August 31, 2011 with refugees and representatives of Benin delegation, applies a pressure, that could not be more tolerable on compatriots.

We say no! to the collaborations on behalf of delegation coming from Africa to repatriate compatriots refugees in Germany. This is one of the reasons, of which there will be an action on behalf of this collaboration in Berlin.

Organizations, Caravan for the rights of refugees and migrant, "The Voice Refugee Forum" and "Flüchtlingsinitiative Wittenberg" that defend the rights of refugees and

migrants in Germany are strongly criticizing and say no! to African countries, including Benin, that send delegations to Germany, under pressure of German government (The Office of Refugees and Migration) to identify African refugees living in Germany for many years, so as to repatriate them to Africa, knowing that they will suffer reprisals after their return to Africa.

Ninety nine percent of countries that accept this sordid collaboration does not meet the rules of human dignity, may God protect us! .

The persistence of this situation is long lasting, and worries us, that it suggests that the state ensures its role to persecute his own son

The refugees, we, are deprived from our right to work and stay, by the foreign office and our district "Lutherstadt Wittenberg" is very conservative, if not ... we avoid the qualification.

Some refugees have no family affiliation in Benin, they are disintegrated socially and economically. They have no accommodation, adding to the dangers of death which they could face in the country.

These refugees may also contribute to the socio-economic development of the country.

We strongly condemn these practices that have caused too much pains to several African refugees in Germany after the return, return that no one wish. We would like that these refugees be treated with dignity. We love our people!.

We believe that as President of the Republic of Benin and Minister, guarantor of equity and law, have the power and means of fulfilling our request.

We plead to accept, Mr. President and Minister, the assurances of our highest consideration and respect.
