FAX MESSAGE OPEN LETTER URGENT

SUBJECT: HUNGAR STRIKE ALERT AND CIVIL DISOBEDIENCE  
BY PRISONERS OF CONSCIENCE BUREN JVA

DEAR SIR,

IT'S WITH INCREASING CONCERN THAT WE DRAW ATTENTIONS ABOUT THE IRREGULARITIES AND THE MISCARAGE IN THE JUDICIAL SYSTEM IN BUREN WITHIN WHICH IMMIGRANTS ARE BEING PERSECUTED UNDER YOUR JURIDICTION.

THERE IS A LARGE CONSPIRACY BETWEEN THE ZAB GERMANY AND THE PADERBORN COURT TO TRIAL IMMIGRANTS ARBITRARY. IT IS EVIDENT THAT VERDICTS ARE PRE PREPARED AND JUST ANNOUNCE TO THE HEARING OF THE PERSECUTED. THIS A SIMILITUDE TO WHAT US TO HAPPENED IN LAWLESS STATES AND PRE-WAR GERMANY.

THE JUDICIAL SYSTEM UNDER WHICH IMMIGRANTS ARE BEING PERSECUTED IS DISCRIMINATORY, AND IT IS A BAD LAW. TO DETAIN AND IMPRISON VICTIMS OF CIRCUMSTANCES, SUCH AS POLITICAL ASYLUM APPLICANTS, VICTIMS OF WAR AND DISASTERS, ESCAPES OF VIOLENCE AND POLITICAL PERSECUTION, UNDER A PRETEX OF DEPORTATION, TO A SUCCESSION OF 3 MONTHS SENTENCES UP TO 18 MONTH IS A BAD AND RACIST LAW.

ARE YOU AWARE THAT, THE METHOD AND MANOUVRE UNDER WHICH THESE IMMIGRANTS ARE DEPORTED IS COERCE, AND NOT CONFORMATE TO INTERNATIONAL STANDARD?

ALSO ARE YOU AWARE THAT ZAB OFFICIALS GIVE MONEY IN EXCHANGE FOR DEPORTATION DOCUMENTS FROM FOREIGN REPRESENTATIVE?

SIR, ARE YOU AWARE THAT IMMIGRANT ARE DEPORTED TO COUNTRIES WHICH IS NOT THEIR HOME LAND?

ARE YOU AWARE OF THE 2003-2004 DEPORTATION SCANDAL IN WHICH GERMANY WAS LARGELY CONCERNED? AFRICANS WERE DEPORTED TO GHANA, 116 FROM DIFFERENT DIMENSIONS. THEY WERE RETURNED BACK TO GERMANY BY THE GHANIAN GOVERNMENT. SIMILAR SCANDAL ALSO HAPPENED IN CONGO D.R AND CAMEROON.

SIR, ARE YOU AWARE THAT SOME AUTHORITIES MANIPULATE THE LAW TO SATISFY THEIR RACIST DESIRES?

AGAIN, ARE YOU AWARE THAT THE IDEOLOGY TO KEEP SOMEONE UNDER DEPORTATION THREATS FOR MORE THAN 3 MONTHS IS TO ELIMINATE THE PERSON SPIRITUALLY AND PSYCHOLOGICALLY?

SIR, ARE YOU AWARE THAT CASES OF INSANITY HAVE BEEN RECORDED HERE IN BUREN AND IS INCREASINGLY HIGH?

SIR, WE DRAW YOUR ATTENTION, THAT A GERMAN CRIMINAL, RAPIST OR MURDERER ETC, MIGHT FACE A LESSER SENTENCE, THAN A VICTIM OF CONSCIENCE KEPT UNDER 1 YEAR DETENTION, FOR DEPORTATION PRETEXT.

WE SAY, THIS IS A GROSS VIOLATION OF HUMAN DIGNITY AND IT IS INTERNATIONALLY UNCONSTITUTIONAL - THIS VIOLATING THE INTERNATIONAL CONVENTION OF HUMAN RIGHT, AND FREEDOM WHICH GERMAN GOVERNMENT IS A SIGNATORY.

WE CALL FOR ATTENTIONS, AND WE HEREBY ANNOUNCE A STRIKE ALERT (CIVIL DISOBEDIENCE, DEATH PRISON AND HUNGRAR STRIKE) FOR THE IMMEDIATE RELEASE OF IMMIGRANTS WHO ARE NOT CHARGED WITH CRIMINAL OFFENCE.

WE ALSO SOLICIT YOUR SUPPORT, AND THAT OF ALL MEN OF GOOD FAITH, HUMANITERIAN ORG, PRESS, AND MEDIA TO PERPETRATE OUR STRUGGLE.

SIR, LOOKING FORWARD TO HEARING FROM YOU SHORTLY.
